From the Chair

The Chairman stated he would like to applaud CEO, Dr. Turner and the staff on the visible progress that has taken place at the school so far this year. He made mention of the noticeable increase in student engagement and involvement over the past few months and commented on the staffs' continued focus on the goal specific outcomes in the areas

of Science, Math and Language Arts. He ended his statement by assuring both the staff and CEO, Dr. Turner, that the Board fully supports and thanks them for their efforts.

CEO'S Report

CEO, Dr. Turner addressed the following:

I. Academics

Dr. Turner informed Board members that preliminary benchmarks/check-ins are complete at this time. Testing data confirms there is an additional need for tutoring in High School math. Dr. Turner says now that we have gotten beyond the social and emotional support, it is time to redirect our focus. She urged Board members and anyone who might know of any College students, retired teachers, or anyone who is really proficient in math and is willing to volunteer their time as a student tutor to contact the school. We also need additional support in the areas of technology and we need K-2 TA's.

II. Operations
